

Seasonal media passes are issued by the FIA Formula Two Championship for those persons working for recognised news gathering media outlets, who regularly cover FIA Formula Two Championship (F2) events. Accreditation will be granted at the sole discretion of the FIA Formula Two Championship Media Delegate and a permanent pass will be issued with the appropriate access to enable the applicant to perform the duties outlined on the various documentation submitted with the application.

Access to the pit-lane during FIA Formula Two Championship sessions and to the starting grid for all races is strictly limited. If you have a need to work in these areas, the reasons must be clearly stated by the editor/publisher requiring you to work and this will be taken into account when allocating working passes, though this access cannot be guaranteed.

Photographers working trackside will be required to wear, at all times, a clearly identifiable garment (media tabard), supplied by the FIA WTCC (Marrakech, Monza, Zolder, Algarve, Brands Hatch, Brno, Oschersleben and Valencia) or the hosting circuit (Silverstone), subject to payment of a deposit.

All passes/media tabards are the property of the FIA or the hosting circuit and are issued subject to conditions and may be withdrawn if those conditions are breached. To be considered for such a pass, please ensure that you meet the requirements listed below and enclose all of the relevant information:

- a) A letter commissioning you to cover the 2010 FIA Formula Two Championship and guaranteeing publication of such coverage, signed by the editor or publisher of the publication. The letter should state in what capacity you will be present: Journalist/Photographer/Radio Reporter/Photo-Journalist. It should also justify any special access required
- b) Cuttings, either carrying your by-line, or substantiated by a letter from the publication confirming them to be your work. In the case of a website, print outs of pages of coverage should be submitted
- c) The publication listed in (a) above must have existed for at least three consecutive editions
- d) Club magazines/publications will not normally be accredited. In the case of free distribution publications, the guideline is a minimum distribution of 250,000 copies
- e) The FIA Formula Two Championship will accredit websites/electronic media at their exclusive discretion, for which the FIA Formula Two Championship may charge a rights fee. (Guidance: web-sites reproducing only press releases will not normally be considered, and those which sell photographs will be required to be licensed, additional to the photographer supplying the images)
- f) The 2010 F2 Media pass permits access ONLY for the purposes of news gathering and reportage by written media and radio reporters. It does not give access for any television/video/film/electronic gathering or any other form of moving picture coverage
- g) The F2 Media pass grants accreditation ONLY for the purposes required in the request provided under paragraph (a) above. It does not grant rights (and such rights are specifically reserved) for the further commercial use of any photographic material, for example, but not limited to, direct sales to the general public, calendar production, etc
- h) In consideration for accreditation you agree to provide six high quality news-worthy images for the FIA Formula Two Championship's royalty free use on the F2 website (and other FIA Formula Two Championship usage) by midday on the day following each F2 race

In consideration of the championship owners, organisers, promoters, sponsors and all connected and associated bodies and companies together with the circuit owning companies staging rounds of the above championship permitting me to have access to certain restricted areas outside of permitted enclosures for the purpose of photography I hereby agree acknowledge and undertake:

- I accept that motor sport may involve the risk of injury or death and that this risk is greater in the restricted areas to which I may have access.
- I accept these risks and will ensure that at all times I will have due regard for my own safety.
- I will not at any time put myself in a position beyond the Armco barrier/tyre wall surrounding the track (trackside) and any such additional protection as provided.
- I will familiarise myself with the circuit, its layout and features before commencing my activities and will satisfy myself that the areas to which I wish to have access are available, safe and suitable for my purpose.
- I understand that this pass permits access ONLY for the purposes of news gathering and reportage by written media and radio reporters. It does not give access for any television/video/film/electronic gathering or any other form of moving picture coverage.
